## Major items discussed:

- 1. Dr. Sutter opened the meeting and thanked everyone for attending. He recognized and thanked Z-Medica for sponsoring the section luncheon again this year.
- 2. Mr. Scott Garrett from Z-Medica
- 3. Dr. Gerardi, the College's Immediate Past-President, introduced the special guest and award winner Richard Carmona, MD, MPH, FACS. Dr. Sutter and Dr. Armando presented Dr. Carmona with the Tactical Section's Visionary Award as the first recipient of the annual award. Dr. Carmona shared some of his experiences in tactical medicine and where he thought the field was headed in the future.

- 7. Reports on other affiliated association meetings included the Special Operations Medicine Association (SOMA) that will be held in Charlotte in May 2016, The new C-TECC guidelines passed and the meeting will partner with SOMA and ALERRT in Nov 2015, IACP Physician Section conference was held Oct 2015 in Chicago, NTOA conference was held in Sept 2015 in Salt Lake City.
- 8. Dr. Mell reported on the new ACEP EMS Education Subcommittee that he is chairing, they will be looking at new EMS, disaster, tactical, and air med courses/presentations as well as working with CECBEMS on EMS CE for ACEP courses.
- 9. Dr. Callaway reported on a hospital response to an active shooter lecture he presented and also discussed an overview of a new proposed project addressing high-threat incidents that brings together EMS, TEMS, disaster medicine, Peds, and international.
